#### Activity: A special on "Awareness of Law"

Date: 20-08-2019

The Anti-Ragging Cell conducted a special lecture on the topic "Awareness of law" on the 20th August 2019 . The member Smt S.K.Jadhav of the Anti-Ragging cell welcomed the guest of the function and also introduced him to all the students of the college.

Then the guest speaker Shri. Parashuram S. Madiwalar, Advocate- Civil Court, Hubli addressed the students. He spoke about how Equality is considered before the law. It essentially means that all people should be treated similarly, regardless of their socioeconomic status, gender or caste. He quotes Article 14 of the constitution.

Article 14 of the Constitution of India reads as under: "The State shall not deny to any person equality before the law or the equal protection of the laws within the territory of India."

While the aforementioned Article directs the State not to deny any individual 'equality before the law,' it also commands the State not to refuse any person 'equal protection of the laws.' Discrimination is prohibited by equality before the law. The cell's main goal is to reduce the threat of ragging by prohibiting, preventing, and eliminating the source of the problem. The college's anti-ragging committee has been on the lookout for sources of ragging and has taken disciplinary action against anyone found guilty of spreading the scourge says the advocate.

The words of the speaker enlightened the students and also the staff about the constitution, act of equality and the disciplinary actions.
